

Beyond Databases

REDCap supports the collection of high quality research/QI data, via:

- Structured data types (text, number, date/time, yes/no, email, ...) drive high quality data collection;
- Tag fields as HIPAA identifiers;
- Min/Max ranges (numbers, dates...);
- Flag "required" fields;
- Calculate values on the fly;
- Create your own data quality rules; \bullet
- Auditing: Project activity is logged, from page views to field edits.
- Restrict user rights to only those needed \bullet for their responsibilities;
- Use Data Access Groups (DAG's) for lacksquaremulti-site studies, allowing site members to see only their data;
- And much more...
